Section: Texas DOT Feedback By Dec 16



Hello,

We hope everyone had a wonderful and relaxing Thanksgiving as we now enter the last month of 2022 and all of those year-end deadlines. Following is an update on a breaking announcement from the Texas DOT and some new database functionality:

1) Yesterday we received an email from the Texas DOT, announcing that they have released draft NEVI program documents, for which they seek feedback by December 16.

TxDOT is developing a competitive grant program to administer the National Electric Vehicle Infrastructure program in Texas.

Texas DOT has not yet set dates for the opening and deadline for the application process – this deadline is just for feedback on their draft application, scoring worksheet, and other documents. There are several interesting things in the [scoring worksheet](#), including:

- Full points for 250 kW per connector
- Full points if installed price is \$125,000 or less per connector
- Full points for restrooms and pull through parking stalls
- Full points for a retail agreement in place for site host
- Full points for the Buy America requirement.

Since 250 kW or higher DC fast chargers cost significantly more than 150 kW, combined with potentially higher deployment costs and the Buy America requirement, Tesla is likely the only vendor that could meet these requirements. Of course, Tesla's Supercharger network does not use the CCS connector but uses its proprietary connector which it now calls "NACS." CCS connectors are a funding requirement of the NEVI program, so Tesla would have to modify its hardware to qualify for the Texas grants.

Section: Buy America Waiver

4) **Buy America Requirement Waiver:** Earlier this week we received a question from a client about the Buy America requirement within the NEVI program related to EV charging hardware. We dove into the question and discovered three things:

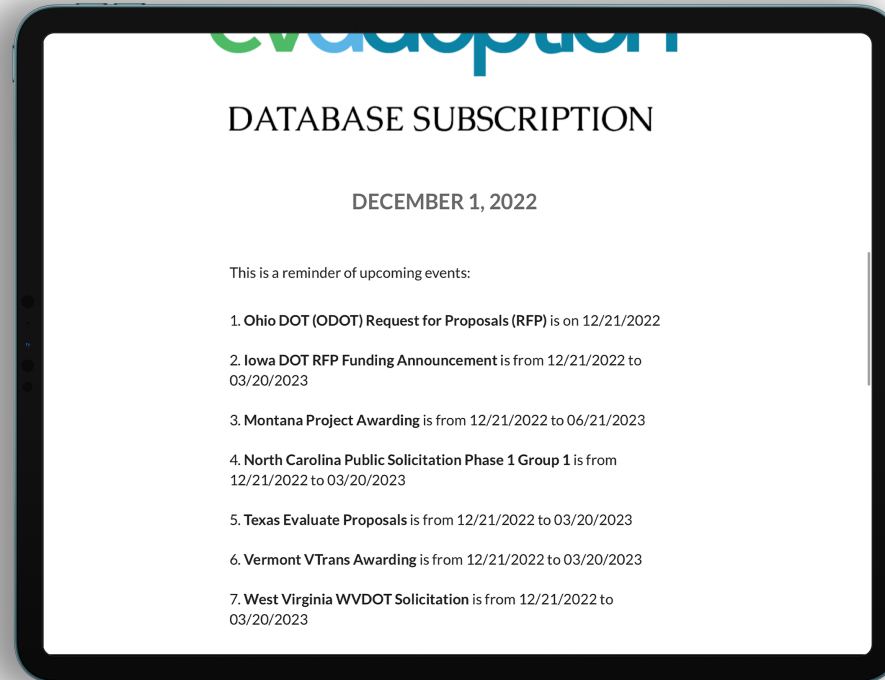
- Within the state NEVI plans we discovered that they had very different takes on the Buy America requirement. In fact, some had a fairly negative commentary towards the requirement saying it's going to be very difficult to meet the requirement and that they would be seeking a waiver.
- We then discovered that [FHWA actually had sought input](#) towards a potential Buy America waiver and set a deadline of September 30 for feedback.
- We then reached out to FHWA for an update and received the following response:

FHWA posted the Notice of Proposed Waiver of Buy America Requirements for Electric Vehicle Chargers in the Federal Register for comments on August 31st with a close date of September 30th. FHWA is currently reviewing comments to determine what course of action is most appropriate. We don't have a verified timeline at this point, but we understand the urgency of the issue and hope to release something by the end of the calendar year.

We will keep clients up-to-date as soon as we hear anything on the waiver.
